During the ongoing COVID-19 pandemic the Archdiocese of Newark continues to serve the young people of the Church of the Holy Rosary in Edgewater.

Parish program facilitators will deliver virtual programming and content for its participants, through online platforms. The program(s) will use software, tools and applications provided by third-parties that participants, parents/legal guardians, volunteers and/or staff will access via the internet and use for purposes of communication, programming, and potential content creation. These platforms may include but are not limited to: Google Classroom, GoToMeeting, WebEx, and Zoom.

To enroll in any of these programs, you must provide your consent and release for your child to participate in these online applications for distance-based, virtual program purposes. Please be aware that each application collects different information about its users and has its own privacy terms and conditions to which members must adhere and which parish or diocese cannot control or assume responsibility. Please review these carefully before registering your child.

Our commitment to keeping the children and youth we serve safe is always our number one priority. To that end, we will actively monitor participant activity of children while engaged in our digital learning platforms. It is parents' responsibility to monitor their child's internet usage as a whole, including their use of any internet sites that are outside of our digital learning platforms. CCD HOUSE RULES

By checking the boxes below, I understand and will ensure that my registered child/children will respect the following house rules for CCD at the Church of the Holy Rosary.

Please check each box to confirm that your child/children will:

- Have the necessary electronic device to participate in Zoom classes.
- Be polite and respect other people's time by signing into their CCD Zoom class at least 5 minutes before classes start.
- Dress appropriately (meaning no pajamas).
- Refrain from eating during the Zoom class. Water is acceptable.
- (To the best of my ability) Be seated in a room with the least distractions during the Zoom class. For example, without television or a handy cell phone to cause distraction.
- Have the necessary writing materials to take notes.
- Keep his/her their video open throughout the duration of the class. If this is not possible, I or my child's guardian (not my child) will explain this to the teacher immediately before or directly after class.
- Will remain seated during class, listening and participating. If a restroom break is necessary, will raise his/her hand to inform the teacher.
- Make an effort to attend Mass every weekend. Masses are celebrated in Holy Rosary every Saturday at 5:30PM and Sundays at 8:00AM, 11:00AM and 12:30PM (Spanish). Watching Mass online or on television is also acceptable when in-person Mass is not possible.

When Using Zoom for Class

For Grades 1 to 3, we strongly recommend that an adult be present to assist the student during class.

When entering the Zoom classroom, children should:

- Wait patiently in the waiting room until the teacher admits the child into class.
- Remain muted. The teacher will control the mute button.
- Note that the private chat feature is disabled.
- Raise their hand, as in a regular classroom, and wait for the teacher to respond to their question or concern.
- Be mindful of the background displayed in their Zoom screen.
